The 10 towers that have been completed as of the last status report have now had all the customers reloaded. We have started work on 10 additional towers; however, some further work on the sites, or additional site acquisition requirements must be fulfilled prior to replacing the equipment. Due to the extreme weather conditions in this remote area of Wisconsin, all construction activities had to be halted in December and will not likely resume until late March.

Country Wireless has not experienced any lack of availability of replacement equipment in the marketplace that threatens its build deadline, however, several of the sites under construction have required new electrical equipment which has been difficult to source quickly. Now as we face the extreme weather in these remote areas, construction activities are currently halted and will not likely resume until approximately late March. * If there is additional information relevant to the preceding questions or that you believe the Commission should be aware of, please include the information below.

The lack of funding became a significant challenge to the timeline. Country Wireless has already been granted an extension to February 2025. Due to winter weather, and now that additional funding has been approved by Congress, Country Wireless plans to file for an additional extension.
