## Explanation of Effort and Availability of Commercial Equipment

\*Provide an explanation of efforts undertaken, and challenges encountered, in permanently removing, replacing, and disposing of covered communications equipment or service.

As Point Broadband Fiber Holding, LLC ("Point" or "We") approaches exhausting its funding, the primary concern is deciding where to stop work until additional funds become available. On December 23, 2024, the National Defense Authorization Act (NDAA) was signed into law with the inclusion of additional SCRP ("Rip & Replace") funding. However, the timing of allocation to participants is unclear.

In the past quarter, Point's primary SCRP focus was on the 2.5 wireless tower swaps. Point successfully completed swaps for 55 tower sites, which accounts for 100% of the total wireless changeouts. As the new equipment was installed, Point removed the Huawei equipment and transported it to the Rip & Replace warehouse for approved disposal. Point completed the fifty-five 2.5 wireless tower swaps with one Core operational. The second Core will be installed in July 2025.

Point's next major hurdle is Fiber to the Home ("FTTH") customer base changeouts. The changeouts will require thousands of truck rolls and contractors to replace the customer-premise equipment. Point is currently hiring more contractors to complete the changeouts. Point formulated a plan to change out the customers on one hub site at a time. Now that additional funding will be allocated, Point is working on a project management plan to complete the changes with a target completion date of December 2025. Point was unable to secure engineering contractors to remove FTTH Huawei chassis and Huawei routers from the network, which are co-installed with the new Ciena equipment. Point attempted to use internal resources to change out some of the FTTH customer premise equipment, but We could not do the conversions and keep up with the other ongoing customer base needs with our limited resources.

Point's DC Plant changeouts were not completed as expected. We ran into difficulties with facility owners and, in some cases, with AC power requirements that did not allow the installation of the new DC plant or required upgrades to the AC Plant. Additionally, Point needs to move non-Huawei equipment attached to the old Huawei DC plant in each hub over to the new DC plant. Our current goal is to complete the Power Systems by July 2025.

Point is a small operator committed to serving rural areas. However, until we are allocated for additional funding approved by Congress, both Point's viability and its customers' access to broadband services are at risk.

Point received the majority of the needed equipment at this time. With additional funding, Point can work toward its biggest issue: finding labor to complete the Rip & Replace project.

Point completed all the Ciena FTTH Hub equipment installations. However, We cannot remove the Huawei FTTH Hub equipment and routers until truck rolls are performed to remove and replace the Huawei FTTH customer-premise equipment. Installations of the 2.5 wireless tower equipment are now 100% complete, achieving our target completion date set for the end of 2024.
