- Applicants are responsible for the continuing accuracy and completeness on information.

- Incomplete or defective applications may be returned. *See 47 C.F.R. §§ 1.934, 1.933.*

- Applicants requesting bidding credits may be required to submit more detailed revenue information when filing their FCC form 601.

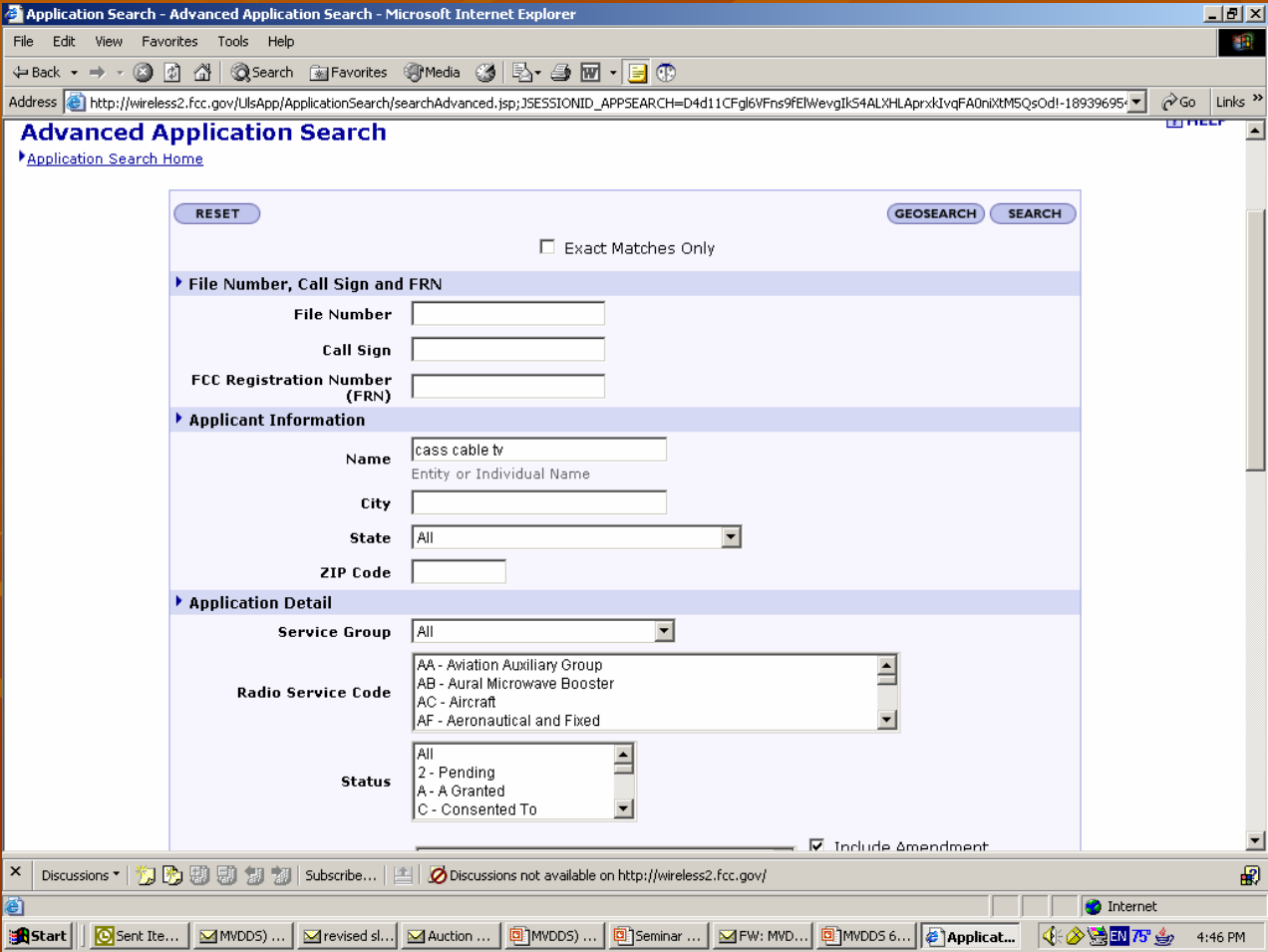

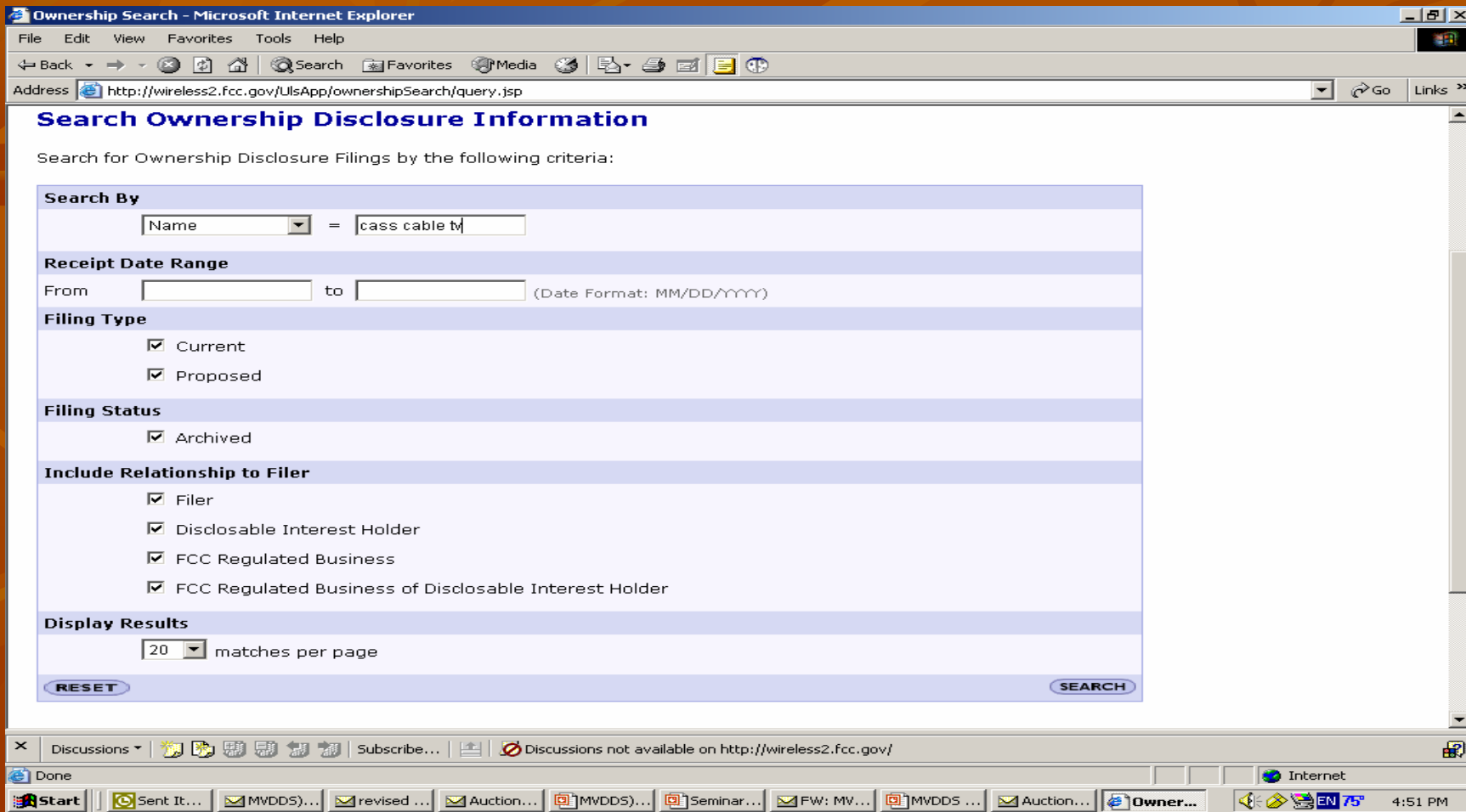
